
# BX - 1100 TYPE 1

#### **DIMENSIONS AND DELIVERY**

The biaxial geogrid shall be delivered to the job site in rol form with each roll individully identified and nominally measuring 4m (13.1-FT) or 4.87m (16-FT) in width and 75m (246-FT) in length.

#### **Notes**

- 1. Unless indicated otherwise, values shown are minimum average roll value determined in accodance with ASTM D4759-02.
- 2. Nominal dimensions.
- 3. Tensile Strength is determined in accordance with ASTM D6637-10 Method A.
- 4. Load transfer capability determined in acordance with ASTM D7737-11.
- 5. Resistance to bending force determined in accordance with ASTM D7748-12, using specimens of width two ribs wide, with transverse ribs cut flush with exterior edges of longitudinal ribs, and of length sufficiently long to enble measurement of the overhang dimension.
- 6. Resistance to in-plane rotational movement measured by applying a 20 kg-cm (2 m-N) moment to the central junction of a 9-IN x 90IN specimen restrained at its perimeter in accordance with US Army Corps of Engineers Methodology for measurement of torsional rigidity.
- 7. Resistance to loss of load capacity or structural integrity when subjected to mechanical installation stress om clayey sand (SC), well graded sand (SW), and crushed stone classified as poorly graded gravel (GP). The grogrid shall be sampled in accordance with ASTM D5818-06 and load capacity shall be determined in accordance with ASTM D6637.
- 8. Resistance to loss of load capacity or structural integrity when subjected to chemically aggressive environments in accordance with EPA 9090 immersion testing.
- 9. Resistance to loss of load capacity or structural integrity when subjected to ultraviolet light and aggressive weathering in accordance with ASTM D4355-05.
